

Bridgwater Without Parish Council

A meeting of Bridgwater Without Parish Council was held at St Francis of Assisi Church Hall on Wednesday 20 November 2013

Present Messer's Hudson, Hooper, Lewis and Councillor Turner.

- 735. Apologies received and accepted from Mr Warner and Councillor Hall.
- 736. Minutes of the meeting held 25/09/2013 were signed as correct record.
- 737. Arising –716/725 clerk to chase bus routes. 726, clerk to email Councillor Julian Taylor Chairman of this committee regarding supporting/funding for these routes. Clerk to chase the statement showing RLT3 monies held by SDC.
- 738. Councillor Turner-Shared information about the ROF plan for BEA Systems to develop into an energy park which will provide local employment for between 4000 and 6000. There will be highway improvements and monies available for a community fund. Bridgwater Hospital on schedule for its March opening date, the road is now open. New Post Office is now also open. The new Police Station is on schedule and may offer employment when open. Councillor Turner asked the clerk to email Clean Surrounds to request removal of tree cuttings left against fencing facing the Westonzoyland Road from properties in Summerville Way.
- 739. Planning- 09/13/00019/NM Orchard House Bath Road Bridgwater Mr and Mrs Kirkpatrick erection of two storey front extension to the SE elevation, no observations, 53/13/00020/STP, Penzoy Farm Westonzoyland, Erection of single wind turbine, measuring 50m to hub with a rotor radius of 27m no observations. Planning appeal, Mr I Tremain, Medway Farm, Chedzoy Lane, Bridgwater, without permission, change of use of an agriculture barn to use for the storage and operation of a scaffolding business and without planning permission change the use of an agriculture building to use for the storage and distribution of furniture, good use of redundant buildings, site used for commercial business, gives employment and improves local economy, no comments to be made.
- 740. Accounts- £17,361 in bank. Community Council for Somerset Mr Hudson asked for consideration to join as the PC would need help with the management of the sports facility at Kings Down. Costs would be approx £35 annually. Proposed Mr Lewis seconded Mr Hooper. Councillor Turner said there was a need to encourage SDC to write a constitution for the facility and to have charity status.

- 743. AOB Kings Down is having a Christmas event, Mr Hudson suggested donating £100 proposed by Mr Hooper and seconded by Mr Lewis. As the community association is not set up yet and banking not fully operational, it was proposed by Mr Hooper that a cheque be written to Mr Hudson to enable him to cash it and give the association the cash. Clerk requested that a receipt is sent to her for accounting purposes.
