# CONSULTATION BEGINS IN SEPTEMBER ON MEADS AND PURITON ENERGY PARK SPDs

This autumn sees the second stage of consultation on the Puriton Energy Park SPD and the first round of public consultation on the idea of creating an enhanced open green space with high ecological and leisure value on the area of land between Durleigh Road and Hamp in Bridgwater, known as the Meads. ## SUPPLEMENTARY PLANNING DOCUMENT

The first stage of consultation on the plans for the former ROF site took place between March and April of this year. The second stage consultation gives another opportunity to see plans, discuss issues further, and have questions answered by planning officers. The online consultation is due to be open on 12th September. Anyone registered on our database will receive an automatic email invitation (see the following page for how to register). ### SUPPLEMENTARY PLANNING DOCUMENT

The new opportunity to enhance the Meads as an open space for recreation and for wildlife is set out in the Bridgwater Vision document, and identified as a key project in the Core Strategy.

Early engagement has taken place with key technical stakeholders and a consultation paper will shortly be available with the idea of gathering as wide a range of views as possible on the best way to use this space. The online consultation is due to be open on 5th September. Anyone registered on our database will receive an automatic email invitation (see the following page for how to register). # The Community Infrastructure Levy

The Community Infrastructure Levy (CIL) is a new system of developer contributions and is intended to supplement other public sector revenue streams to ensure that new community infrastructure can be provided to keep pace with population growth.

CIL will be a standard charge per square metre applied to new developments imposed at the time planning permission is granted and paid at the commencement of development or, for larger amounts, by instalments over fixed time periods. Affordable housing and building used by charities are, however, exempt from paying CIL.

The level of the tariff is set by the local authority based on the needs identified in its infrastructure delivery plan, but also tested to ensure that it will not affect the viability of developments. Planning obligations will still be used for site specific mitigation measures that are required to make a development acceptable (such as a new access road) as well as for affordable housing provision.

It is estimated that the process of preparing a CIL Charging Schedule (given the need for consultation and formal examination) is likely to take around a year to complete and adoption at the earliest would be December 2012. The CIL Charging Schedule will replace the previously proposed Planning Obligations DPD. In the interim the current obligation 'tariffs' for flood defence in Bridgwater and for open space and outdoor space (under Policy RLT2 and 3 of the Local Plan) will remain in place whilst other infrastructure requirements will continue to be secured through S106 agreements on a site specific basis.

# **NATIONAL NEWS**

The much talked about Localism Bill is currently making its way through Parliament and is due to be given Royal Assent in November. There may be several changes to the Bill by the time it becomes law, but its impact on local planning is likely to remain significant, particularly in its facilitation of **Neighbourhood Planning** and its granting of the community right to build local housing and to bid for local services that are under threat. You can keep up to date with the progress for the Bill at http://services.parliament.uk/bills/2010-11/localism.html and download a copy of 'A Plain English Guide to the Localism Bill' at http://www.communities.gov.uk/publications/ localgovernment/localismplainenglishquide. Meanwhile, the Government is consulting on the first draft of the National Planning Policy Framework, which will replace existing national planning policy, condensing all current PPSs, PPGs and Circulars into about 50 pages, and giving a presumption in favour of sustainable development.
