Anti-social behaviour crime within the local area is also an issue, a skateboard park at this end of town has been suggested as a possible solution for the young. There are no staff allocated to the LCN's therefore moving ideas forward may prove difficult.<br>Somerset council have made changes to car parks which has reduced spaces by approximately 80, which results in £183k reduction in income.<br>Buses in the area have been unable to take contactless payments which has resulted in many people being able to travel free. |                    |
